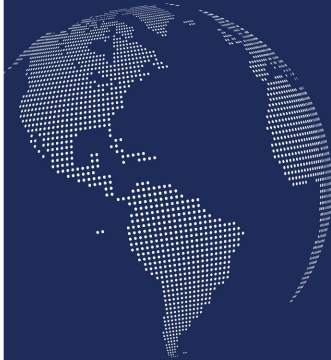

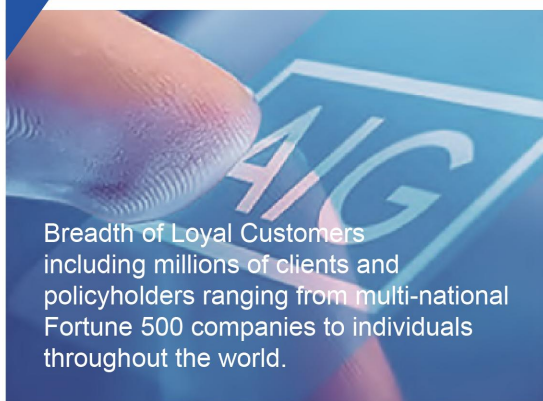

# China Overview

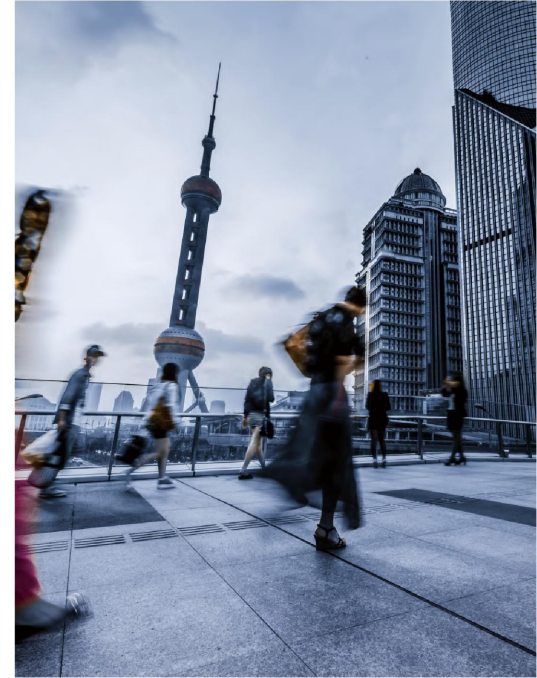

# AIG in China

- ▶ The American International Group (AIG) can trace its roots back to 100+ years ago, when American Cornelius Vander Starr established a general insurance agency, American Asiatic Underwriters, headquartered in Shanghai, China.
- ▶ AIG markets its brand in China as Mei Ya. “Mei” means “American”, and “Ya” means “Asiatic”.
- ▶ AIG was the first foreign insurer in China to receive a license to operate in the market in 1992.
- ▶ In 2007, the former China Insurance Regulatory Commission (CIRC) approved conversion of all branches of AIU in China into a wholly owned subsidiary of AIG in China.
- ▶ AIG celebrated its centenary in 2019.
